ACTIVITIES AUTHORISED BY THIS PERMIT

This permit is issued for the purpose of educational and community awareness programs. It authorises the permit holder or "Agent" (student or employee of XXXX School), directly authorised by the permit holder, to take and possess fish not more than the numbers specified in Schedule 1, of any size, from State waters in accordance with the terms and conditions set out below.

CONDITIONS

It is a condition of this permit that the permit holder -

- 1. must not take and possess more than the species designated in Schedule 1 during the permit period.
- 2. must ensure that all Agents comply with the conditions of this permit.
- must not conduct any activities under this permit within Marine Nature Reserves or Marine Resources Protected Areas.
- must not conduct any activities under this permit within Taroona waters (otherwise known as Crayfish Pt. Reserve) or designated research areas without the prior written approval of the Director (Marine Resources).
- 5. must not take any prohibited species as prescribed in the Fisheries (General & Fees) Regulations 1996.
- 6. must keep a copy of this permit on their person at all times whilst taking fish under the authority of this permit.
- 7. must, with the exception of Condition 8 and Condition 9, only take fish under the authority of this permit using fishing gear that equates to that approved for the recreational take for that

- particular species, and the permit holder or Agent has the appropriate recreational authorisation to use that particular equipment.
- 8. may use a dipnet that has a mesh size less than 20 mm.
- 9. may use a beach seine net equating to and in accordance with Fisheries (scalefish) Rules 2001, as if the permit holder possessed a Fishing Licence (recreational beach seine).
- 10. must return to the water immediately, with as little damage as practicable, all bycatch species.
- 11. may obtain rock lobster and abalone from authorised staff of the Tasmanian Aquaculture and Fisheries Institute, Taroona.
- 12. ensure that the quantities collected under the permit do not exceed those necessary to provide for teaching and display purposes.
- 13. must ensure that all marine species taken under this permit are held on the school premises unless given expressed written permission from the Director (Marine Resources).
- 14. must not sell or transfer marine species taken under the permit unless given the expressed written permission by the Director (Marine Resources).
- 15. must contact in writing: the Marine Police, Hobart (fax 03 6230 2598) and the Director Marine Resources, (fax 03 6223 1539), at least twenty four hours prior to conducting any activities under this permit, providing permit number, details on date, time, fishing method and the proposed area(s) of operation and the vessel being used; and retain proof that the facsimile was received by the Director (Marine Resources).
- 16. must provide in writing on school letter head (or in any other manner requested by the Director Marine Resources) details of the area(s) of collection, the date and species taken within 24 hours of landing any abalone or rock lobster taken under this permit, and retain proof that the facsimile was received by the Director.
- 17. must keep a copy of this permit on display near the aquarium system.
- 18. must ensure that no fish taken under this permit are released back into State Waters without the express written approval of the Director (Marine Resources).
- 19. must supply the Director (Marine Resources) with a complete and accurate report, noting the details of the area(s) of collection, mortalities incurred and the numbers and type of specimens collected pursuant to the period within one month of the end of the permit period.
- 20. shall permit any officer from the Department of Primary Industries, Water and Environment to have access at any reasonable time to the fish taken, vessels and to any records relating to activities under this permit.
- 21. must comply with the Living Marine Resources Management Act 1995 and all regulations and rules made thereunder with exception of activities explicitly authorised by this permit.
